_____ I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the Centers for Disease Control and Prevention (CDC) and many other public health authorities recommend being fully vaccinated, practicing social distancing, wearing a mask and frequent hand washing.

_____ I further acknowledge that NHBCOS has implemented preventative measures to reduce the spread of the Coronavirus/COVID-19 among members while attending rehearsals.

_____ I further acknowledge that NHBCOS cannot guarantee that I will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, NHBCOS staff, other NHBCOS members and their families.

_____ I voluntarily agree to meet with NHBCOS for music rehearsals scheduled by NHBCOS and acknowledge that I may be increasing my risk to exposure to the Coronavirus/COVID-19.

_____ I attest that:

1. I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, muscle pain, headache, sore throat, or new loss of taste or smell.
2. I have not traveled internationally within the last 14 days.
3. If I do experience any symptom of illness described in item 1 above, I will not attend the rehearsal for that week. If I do travel internationally, I will not attend the rehearsals for 1 week following my return.
4. I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19 within the last 14 days.
5. If I am fully vaccinated against COVID-19, I do not need to wear a mask or distance in most places, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.

_____ I hereby release and agree to hold NHBCOS harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the organization, or that may otherwise arise in any way in connection with any services received from NHBCOS together with all members, partners, and employees.

_____ In the unlikely event that an outbreak of COVID-19 occurs among NHBCOS members which warrants temporary closure of our current session according to El Paso County Health guidelines, all rehearsals will be temporarily suspended while NHBCOS works with county and state health agencies for their guidance in managing an outbreak. If rehearsals are canceled for the remainder of the session, a pro-rated refund may be given to each registered member.
